Council Member Allen made a motion, seconded by Council Member Holland to approve the July 2024 financials for payment. The motion carried.

Council Member Holland made a motion, seconded by Council Member Allen to approve Blake and Amanda Aaron's application to place solar lights on their buildings in the historic district. The motion carried.

Council Member Allen made a motion, seconded by Council Member Holland to approve the water department to apply credits from the customers water bill to their sewer bill and issue refunds for any amount left over and to waive any late fees for those customers for the month of August. The motion carried.

Council Member Allen made a motion, seconded by Council Member Phillips to approve paying half the cost of transportation and disposal of chemical totes that the town can not use. The motion carried.

Council Member Nevels made a motion, seconded by Council Member Walker to approve ending the contract with JCP Management for management of the sewer plant and having the town take over the management of the plant and hiring Greg Thompson as a full-time employee for the sewer plant. The motion carried.

Council Member Holland made a motion, seconded by Council Member Allen to approve paying for a mandatory password protection program for police officers and staff. The motion carried.

Chief Russell gave his monthly report to the council and also asked to be approved to hire two officers in order to have a total of six full-time officers. Council Member Holland made a motion, seconded by Council Member Phillips to approve the Chief to hire two full-time police officers. The motion carried.

Council Member Holland made a motion, seconded by Council Member Phillips to approve a quote from Scott Harper to replace flooring in the Legion Hut kitchen for \$2,214.69. The motion carried.
