Council Member Allen made a motion, seconded by Council Member Phillips to approve the November 2023 financials and bills for payment. The motion Carried.

The Council reviewed a letter from the Zoning Commission Chairman regarding the application from Karen Fryer (Y MAK LLC) requesting to have her property at 609 Main Street, Oak Grove re-zoned from R-1(residential) to Commercial in order to sell the property for a drive-thru restaurant. The Zoning Commission voted at their meeting 5-0 to recommend disapproval of the zoning change.
